What We Cannot Accept

- Dirty, damaged, or unsafe items
- Chewed or destroyed toys
- Open food or treats
- Expired products
- Recalled items
- Severely worn gear, or missing parts
- Prohibited training equipment

1. Program Overview

Pawparazzi Pet Services ("Pawparazzi") agrees to display and sell approved, gently used pet-related items on behalf of the Seller under the Thrifty Animal Consignment Program.

All items are accepted at the discretion of Pawparazzi and must meet established quality, safety, and cleanliness standards. Acceptance of any item is subject to the terms and conditions of this agreement.

2. Ownership of Goods

All consigned items remain the property of the Seller until they are sold or until the end of the consignment term. Pawparazzi is not responsible for manufacturer defects, hidden flaws, or normal wear and tear.

3. Commission & Payments

Commission Split:

- Seller: ____% of sale price
- Pawparazzi: ____% of sale price

Payments are issued monthly via e-transfer, unless otherwise agreed.

4. Pricing & Discounts

Pricing is set collaboratively between Pawparazzi and the Seller based on item condition, demand, and comparable retail pricing. Pawparazzi reserves the right to apply reasonable markdowns to support timely sales.

Optional discount schedule:

- After 30 days: up to 10% reduction
- After 45 days: up to 20% reduction

5. Consignment Term & Unsold Items

The standard consignment term is 60 days from the intake date.

Items may not be removed by the seller before the term is complete.

At the end of the 60-day term, Sellers are responsible for collecting unsold items within 14 days of notification. Items not collected within this period will be considered abandoned property and will become the property of Pawparazzi.

Pawparazzi may then donate, dispose of, further discount, or sell these items at 100% commission. No compensation will be owed to the original Seller after this period.

6. Care & Handling

Pawparazzi will take reasonable care of consigned items, including basic cleaning, sanitation, and professional display (space permitting). All accepted items are inspected and sanitized before being displayed for sale. The Seller acknowledges that minor handling wear may occur during normal retail activity.

7. Liability Disclaimer

All items are sold "as-is." Pawparazzi assumes no responsibility or liability for:

- Product defects
- Improper use
- Allergic reactions
- Injury related to product use

The Seller agrees to release and hold Pawparazzi harmless from any related claims.

8. Right of Refusal

Pawparazzi reserves the right to decline any item, remove items from sale, or terminate this agreement at any time. These actions may be taken for quality, safety, business, or operational reasons.

Agreement Acceptance
